2020 ANNUAL REPORT MUSIC DIRECTOR

Perhaps like many others writing their reports, I will simply begin by stating that 2020 was an unprecedented year for everyone including Eastminster. The pandemic has brought about changes in how we engage in worship and what it means to actively participate in the service. I am grateful to have been a part of the Task Force for Reopening that helped create the protocols that have allowed us to worship together either in person or online. While the pandemic has certainly changed how we do things, I would like to bring to your attention some of the highlights from music.

- March 1: men of the Eastminster Choir offering the gospel anthem, "I Must Tell Jesus" which featured our tenor section leader, Isaac Cooper.
- March 15: Section leaders of Eastminster Choir offered the anthem, "Lead Me Lord." This was the last anthem sung in worship before covid closed Eastminster.
- Special music created and offered both on the Eastminster facebook page as well as during the pre-recorded services between March and June.

One of the biggest undertakings was the Christmas Eve service. The music featured a wide range of members and musical styles. This was an opportunity for congregants to share their talents in worship. Moving forward, I am excited to create more opportunities for the congregation to share in worship in this way.

As the choir has been shuttered during the pandemic, we have had opportunities for fellowship via zoom. I am eagerly counting down the days until we can safely gather and create music once more. Although not much of an expense this year, Eastminster does have three scholarship singers. In 2020, our tenor, Isaac Cooper, graduated. I am happy to report that Isaac has been attending graduate school for in North Carolina and thriving. Our alto scholarship singer, Alex Smith, was gracious enough to lend her voice to our Christmas Eve carols. Looking forward, these scholarship singers will be an important part of the music program as we move beyond covid.

As soon as it becomes safe to do so, I would like to offer supplemental opportunities for music. Since it will be more than a year since many of us have sung with any regularity, I would like to offer evenings or afternoons where people can come and sing as a group. It does not have to be choral music, but just a chance to sing devotional music that will help rebuild voices that have been silenced for a while. Further, I would like to start working on creating a children's choir that will be in worship each quarter.

I would be remiss if I did not mention the efforts and work of our organist, Rachel Luttrull. As we navigated moving to online worship and then back again, Rachel was an integral part of all of our efforts. She spearheaded making audio recordings for the pre-recorded services and helped troubleshoot the livestream issues we had early on. Eastminster is incredibly fortunate to have such a devoted and talented organist.

As a congregation that has a strong choral tradition as well as a reputation for being a "singing" church, we have had to grow and adapt until it is safe to make music together. I see much reason to be hopeful with the rollout of the vaccines that we will be drawn together in song and fellowship soon.

2020 ANNUAL REPORT YOUTH DIRECTOR/ PASTORAL ASSISTANT

To say that I am disappointed with 2020 would be an understatement. Our Youth Group started the year off strong: attending Sister Joanna's Table; fun events such as nerf wars and lock ins; and off course, meeting for weekly study and fellowship. The youth's weekly attendance average was 18 before March of 2020. Our least attended week being January 5th 2020 had an attendance of 7. Our highest, ironically, was March 1st 2020 with an attendance of 29. However, 2020 rained on everyone's parade and the youth were no exception.

Of course, closing Eastminster was unexpected and the youth program was not prepared to roll with that punch. We quickly began a weekly Zoom Bible Study; however, that was mostly unsuccessful. Getting the word out about the meeting was the first challenge and even though I keep a record of parent contact information I also try to keep direct lines of communication open with the youth. It was very difficult to coordinate and communicate meeting times. Our highest attended Zoom meeting was 7 strong and unfortunately on several occasions no one would log on at all. With that being said, I'm glad the option was available for the youth but it was a far cry from our typical fellowship experience. The fact that everything (school, social life, etc.) had moved online, nobody could blame the youth for not wanting to be behind a computer longer than needed.

On top of having to restructure the youth program, difficulties in the church often forced me to put the youth on the back burner. Although I was not without help, over the last two years most of the pastoral duties landed on my shoulders. This was particularly rough when the shutdown first occurred and we were closed completely. Even once we reopened and a new routine began to form, I often found myself taking care of pastoral duties such as preaching, leading worship, assisting staff/volunteers, making visits, working with funerals, and whatever else that came my way. Because of this, it left little time for me to focus on the youth program during normal office hours. Most of the planning and restructuring for the youth program was being done on my own time. I am ashamed to admit this, but that meant that more often than not, the youth group became an afterthought.

Even though things became discouraging, our youth program has had a long tradition of being resilient and we eventually managed to reopen and find a new stride. Albeit a less personal, socially distanced, stride that requires a mask! A "pandemic protocol" which was heavily inspired by the EVSC was implemented. Although things are more tedious now, the ball is rolling once again. Our attendance has been unpredictable and inconsistent, which I suppose is to be expected, but it has done little to hold us back.

We have begun serving at Sister Joanna's Table again, although it is quite different then the way it used to be. We have managed to pull off some parties and fun days that I have found to be even more important than they used to be. Although fellowship has always been a priority for the EPC youth, many of the youth have expressed that these "let's just have fun" days have improved their mental health.

Many youth either feel or are isolated even though they are able to attend school in person. Having a youth program gives them a structured and safe outlet.

Because of this, we have stopped looking out into our community for mission opportunities and have focused more inward.

With the assistance of Annie Engelbrecht and the Children's Fellowship Committee, we have begun having boy/girl Bible Studies and fellowship times. This has proved to be a good fit in helping us to engage with each youth on an individual level as well as in a small group setting. This also helps me make sure our weekly youth group is meeting the needs of those attending. It has really helped in filling the void left by losing our weekly office hours where the youth could come just to "hang out."

Like many of you, when I look back over last year -- both professionally and personally - it all just seems like a blur. However, with new leadership inside the church and a new year before us, I can only anticipate us coming out stronger than ever (both the youth program and the congregation). It is very difficult, under the circumstances, to include plans for 2021. I can say, however, that we hope to continue our Boy/Girl Bible Studies and events. I really hope to get office hours started again in the near future. Although we have not formed any new connections with our community, we will continue pursuing the old. Many of the things we cannot do anymore are being phased out for new things.

We have become more introspective as a group and having gone through this shared suffering it has bonded us. 2020 has forced us to consider how important our relationships are with one another and in 2021 Christ will remain the central focus of our Youth and education will be highly prioritized.

I have been preaching that those of us in the youth program (adults and students alike) are always there for one another. This past year not only tested that but PROVED it. With the affirmation of our friendship and the confidence we have gained in each other I can honestly say that I have no idea what 2021 is going to bring -- but it's going to be awesome.

It was a sad year on one hand with the death of the following people from Eastminster. On the other hand, it is reassuring to know that God has called them home. Those members were: Susan Baker, Jane Ball, Barbara Barrett, Ed Diamond, Barb Ferguson, Max Foley, Virginia Foley, Sue Goodloe, Al Grabhorn, Vicki Humphrey, Tracey Manis, Mary Lou Matzen and June Tate.

Much work has been done to begin the clean-up of the church rolls in 2020, with tremendous help from Stacie Schalasky, Mary Fulkerson, and Patsy Sproatt. Using the church's official membership roll book as well as the church's electronic database, the clerk compiled a list of 339 names. Of these, 13 had already been removed from the rolls with session approval but had not yet been removed from the roll book. This gave us a starting membership for 2020 of 326. Upon further analysis of this list, there were 8 people who are deceased and were never removed from the rolls. In the first part of the year, a survey was sent to all active members who had not attended recently. These surveys resulted in 17 people asking to be removed from the rolls. 51 more members were removed because they had not attended church in at least 2 years.

2020 ANNUAL REPORT BOARD OF DEACONS

The office of Deacon enables members of our congregation to step up and help and look after other members of our church, truly making us the Body of Christ. For the 2020 year we had many challenges to overcome and our members were asked to think outside of the box to help bring our congregation together in a time of separation. I am so very proud to have served with the following individuals: Brian Bailey, Karen Blume, Jo Chaddock, Lannie Frasier, Ralph Frasier, Suzette Fritz, Sabrina Holden, Suzanne Lokey, Jayne Manis, Carolyn Tyring, Diane VanCleave, Debbie VanZandt, and Kim Weil. They tended to the members of their "flock"; a group assigned to them from the membership of the church with new members being added as they joined throughout the year. The Covid Pandemic changed the way we did everything this year and we hope to be able to make further changes to help tend to our flock members while following safe practices to help keep everyone safe.

In addition to serving individual members of our congregation, the Board of Deacons serves the church by providing support in the areas of:

- Communion Chaired by Diane VanCleave & Brian Bailey the preparation and cleanup of the elements for the first Sunday of the month communion, Maundy Thursday services, and Christmas Eve services. Two members prepare the elements for each service, clean up the table, and take care of each piece of the communion service pieces. Not having any type of communion was a concern for all the Deacons during a time when we were unable to meet and safely distribute the elements.
- Chancel Flowers Chaired by Jayne Manis two members volunteer to make sure the flowers purchased for any service in honor or memory of individuals are either presented to those whom purchased the flowers, distributed to other individuals that the purchaser as asked to be delivered to, or given to an individual of their choice. One of those two also attend the monthly Session meeting for their assigned month to let them know what has been happening with the Board of Deacons.
- Compassion Dinners Chaired by Suzanne Lokey the Deacons are always on hand to serve the family of those we have lost by either providing food trays at the funeral home or by having a dinner at the church following the service per the family's request. While the responsibility falls to the Deacons, we have several members of our congregation that will provide food but also help with setting up beforehand and cleaning up afterwards. Since we were unable to meet within the walls of the church for these important dinners, we had to come up with alternative plans for our grieving families. After much discussion, we decided to provide food at the funeral home or be delivered after the service to their home for any family that chooses.

Not only do the Deacons serve the members of our church family, they serve as community outreach for the face of our church through the Good Samaritan Fund and the annual Christmas Basket outreach.

- Good Samaritan Fund the fund monitored by the Deacons and is garnered by the loose offerings that are given on communion Sunday for the first six months of the year. Throughout the year, individuals that need temporary and emergency assistance from our community are given funds at the discretion of the Pastor and/or Mary Fulkerson.
- Christmas Basket Outreach Chaired by Sabrina Holden this program is a major undertaking that provides food and gifts to children attending Caze Elementary School and members of their family. Because of the restrictions in place because of the pandemic, this was a different undertaking as well. After much discussion with the counselor at Caze, it was suggested that we provide each child with a pair of uniform pants, a uniform shirt, a toy, and a book.

Each child also received a \$25 gift card to Ruler Foods for the purchase of groceries. All items were packaged together and delivered to the school; the school then delivered to each child on the last day before break. Between the Angel Tree with children being bought for individual members and the funds available in the Deacons fund, we were able to provide gifts for 27 children from Caze Elementary and 7 children from our congregation.

The Board of Deacons also added an event to our calendar that we hope to make an annual event; the "Because We Love You" luncheon. We were able to provide a sit down lunch for the members of our congregation after service and give everyone a chance to eat and socialize together. This meal was provided by the Deacons and a free will offering was taken to help defray the costs of future events for our congregation. In an effort to keep everyone in touch during the pandemic, a private Facebook group was also created for a place for everyone to share and keep in touch. 2020 turned out a lot differently than we thought it would and we have tried to evolve and continue to support our flock in new and different ways. I hope to be able to get back to a new normal and serve with open hearts to the members of our church.

The Board of Trustees hold title to all Eastminster Presbyterian Church properties which are held in safe keeping at the Church.

The Board is responsible for the insurance coverage of all Eastminster Presbyterian Church facilities and all liability needs. A new agency was chosen this year which provides superior coverage for our church.

The Memorial Committee, a sub-committee, is chaired by a member. This year a chancel cloth was purchased with some of the funds.

The Board of Trustees administers the Endowment Fund under the direction of the Session. The Endowment Fund was previously invested at Old National Bank and is now invested through Ameriprise Financial. After much deliberation, the Trustees felt that our investments could be better served at another institution due to Old National Bank's fee structure for us and lack of growth in the value of our portfolio.

The following were completed in 2020:

- An anonymous person installed a new door closer on the Men's restroom door on the 2nd floor. Thanks!
- An electrician from Shekell repaired the lights that illuminate the Cross in the Chancel.
- The exterior sill below one of the Narthex windows and a few facia boards on the Gallery were replaced by an anonymous donor – Thanks very much!
- Several ceiling tiles in Totten Hall were showing signs of old water leaks (to the best of our knowledge, these leaks were old and no longer active). Mike Cantrell cleaned and painted them with a special paint product that Gary Van Zandt donated. Thanks to both Mike and Gary!

The areas of responsibility for the Christian Ed Committee include Sunday School for all ages – including adults, the décor of the classrooms, special programs, and children's worship.

Sunday School is comprised of 3 adult classes, 1 youth class and 2 children's classes. The Sunday School superintendent is Matthew Fiedler.

Children's classes:

Pre-K through 2nd graders taught by Gordon Wiley 3rd – 5th graders taught by Kim Weil Middle School and High School taught by Trey Fulkerson

Adult classes taught by:

Chris Kuhs, Diane & Jim VanCleave, and Interim Pastor Scott Solether. It is uncertain at this time if the Interim Pastor's Sunday School class will continue with Pastor Silence or another teacher when we are able to attend in person again.

Sunday School attendance for 2020 (winter quarter) totaled an average of 48 before the Covid-19 Shelter in Place/Pandemic. This average was lower than 2019. There has been no in person Sunday School since March 2020, and therefore, no spring, summer or fall quarter averages.

Children's Sunday School Curriculum used was "Loving God, Loving Neighbor" by Abingdon Press.

There was no Summer Sunday School this year.

The only Special programs this year were:

The Memory Work Challenge-Scripture memorization for children and youth with 9 students receiving awards. The Challenge was suspended for several months and restarted with an end date well past Lent, Nov. 8.

A Pandemic Adapted Halloween Carnival/Movie Night open to EPC members and the community.

An Advent Booklet, "A New Light Shines" by Connie Clark was provided to the congregation. No Advent Luncheon was able to be provided.

We were unable to provide the Annual Easter Egg Hunt, VBS or any other special programs due to the Covid-19 pandemic.

2020 ANNUAL REPORT COMMUNITY & WORLD MISSIONS COMMITTEE

To report that 2020 was a year of challenge would be a gracious way of describing the past twelve months. The first meeting of the Committee was held in February and, sadly, that was also the last meeting in 2020 as COVID-19 grew from an epidemic into a pandemic which early on led to the suspension of in-person meetings and even in-person worship until mid-June.

However, the Committee was not rendered totally useless despite the upheaval caused by the pandemic. Prior to being shut down as a "red zone," Eastminster was able to safely host a blood drive for the Red Cross which was a valuable contribution to the community as demand for blood grew rapidly when the number of COVID cases grew.

The pandemic also affected worship attendance, which affected church giving. The Committee was, however, approved to continue to make gifts to the missions we have supported. In 2020, the Committee awarded a total of \$24,794 to 21 different organizations and in keeping with the Committee's pledge to make Eastminster's giving more personal, the majority of those checks were delivered personally – not just mailed.

In April of 2020, the Mission Study Committee recommended that the church increase efficiency by combining some committees. The Community & World Mission Committee has begun discussion to that end with The Outreach Committee.

Projects Completed During 2020

- Installation of new downspout discharge drain lines around the building was completed.
 Rerouting and burying the sump pump drain line as a part of this project was completed.
- 2. Removal of the playground walls, grading for yard and laying of the sod was completed.
- 3. The Sanctuary HVAC system with a new air handler was installed and is operational.

2021 Projects

4. A contractor for the replacement of the water damaged fascia, soffit and gutters has been identified pending acceptable design of the components. This project cost is expected to be in the 40-50k range.

Future Projects

5. A new ADA concrete ramp and landing at the Totten Hall east entry, sealing and relining the parking lots and replacing/upgrading the church security system are projects being considered for the future.

2020 ANNUAL REPORT OUTREACH COMMITTEE

The Outreach Committee is responsible for the following areas:

1. Attracting people to Eastminster:

a. Through advertising, special events, social media.

2. Visitors' first impressions of Eastminster:

- a. While not directly responsible, we do have an interest in the way the building and grounds are maintained.
- b. The book "Guide for Greeters & Ushers" needs to be available for all volunteers.

3. Follow-up procedures for Visitors:

- a. Any visitor that signs our attendance pad in the church pew on Sunday morning with enough information is sent a Welcome Letter the following Monday. The office will notify the committee
- b. If or when the visitor returns, the office (Toni McClees) reports to the Outreach Committee.
- c. A member from the committee takes a loaf of bread (Great Harvest) with a kind note to their home inviting them for a tour of the Church and to meet the Pastor.
- d. The Pastor calls visitor after third visit to see if there is interest in membership.

4. New Member Seminar:

- a. Assist Pastor with letters of invitation
- b. Help with membership class
- c. Host the reception after Sunday service
- d. Write brief bio for the weekly newsletter

5. Baccalaureate for Harrison High School:

- a. Eastminster in the past has offered to do the service and provide a reception immediately following in the gallery.
- b. This was cancelled due to COVID.

6. Holiday Yard Signs:

a. This event did not happen due to COVID. But we should continue in 2021.

7. Strawberry Festival:

a. Outreach has the task to assign volunteers for the various committees. Unfortunately, this event didn't happen. There is more information in the 2019 report by Brenda Miller.

The Committee accomplished the following in 2020

- 1. Updating Church Roster
 - a. Letters were sent to church families requesting any changes in contact information such as address changes or family members who have moved on to other churches
- 2. Welcome Gifts New idea this year.
 - a. Eastminster mugs with a pen, note from Outreach tied up in a clear bag. Greeters would offer them to 1st time visitors

Finally, it has been recommended thru the Mission Study report that the Outreach Committee and the Community and World Mission Committee should discuss the idea of merging. We met late fall with interim Pastor J.T. Silence to start the discussion. To be continued in 2021.

2020 ANNUAL REPORT PERSONNEL COMMITTEE

Committee members: Marilyn Ellsperman (2020), Melissa Mattingly (2022), Harold Post (2020), Corinne Smith (2020), and, Patsy Sproatt (2021). Jack Turpin (2022) was appointed by Session but resigned early in the year due to health issues.

The first three months of 2020 were active for the Personnel Committee. The matter of insurance benefits to full time staff was resolved with the assistance of an Ad Hoc committee with the decision being that due to budgetary restrictions EPC is not able to provide that benefit. We took a step toward hiring a new CE Director by requesting that the CE committee meet with us to discuss their thoughts on that position. And, we discussed issues brought to us by the Budget and Finance committee and the Mission Study committee, both looking at the bookkeeping/budgeting process as it applies to staff. In response to their requests, we created a two-week time study process and requested each committee member as liaison to implement this with his/her staff member. The nursery worker was also to be asked, at the request of the BF Committee, to obtain a work permit, as she is underage.

Of most concern, also beginning early in this time period and continuing, there was discussion of issues brought to committee members by both parishioners and staff regarding the pastoral and working relationship with (Interim) Pastor Solether. These issues were not resolved and Pastor Solether met with us at our request, along with Alan Finnan of the Presbytery Committee on Ministry, to hear and discuss those. We were then asked to make a report to Session.

By mid-March the church was closed for in-person gatherings due to the spread of the Corona virus and Session meeting that month was held via Zoom. During that meeting we learned that Pastor Solether, due to his health issues, would be eligible for disability assistance through the Presbytery and could begin his leave at the end of the month. The time study was put on hold and later cancelled as the Mission Study committee had completed its work. As there was no nursery care needed, there was no longer a work permit issue; and the search for a CE director was suspended indefinitely.

Despite the pandemic, most staff members continued their work in some way as we immediately began to offer a taped or later live-streamed Sunday morning service, which continues. Trey Fulkerson, as Pastoral Assistant, stepped in to lead those services and to act in the pastoral role as much as possible and continued to do so until November when our new Interim Pastor, J. T. Silence, began. Alanna Keenan, Music Director, has provided (or arranged for) vocal music and Rachel Luttrull, Organist, has provided organ, piano, or instrumental music for each service, including our Christmas Eve service.

Marian LaChance and Mike Cantrell, our custodial staff, have varied their hours to accommodate the need and mainly have kept the sanctuary and office areas sanitized following use, and in addition have completed some major tasks needed and attended to maintenance.

Mary Fulkerson, Office Manager, has also worked a varied schedule at times, but has continued to complete the tasks necessary to support other staff; to be available to church members in the absence of a Pastor; to keep members informed as fully as possible via the electronic and/or mailed newsletter, and to continue to manage the financial matters. We are grateful to each of our staff members.

Pulpit supply: The committee was responsible for finding and scheduling people to provide the sermon during the period of January through October while a search committee looked for an interim minister. Those who filled the pulpit during this period were Chaplain Gabe Cotton, Rev. Joe Easley, Rev. Alan Finnan, Trey Fulkerson, Allen Helmstetter, Rev. Cliff Herring, Shannon Irmscher, Rev. Wendy McCormick, and Rev. Shane O'Neill. Special thanks to Youth Director/Pastoral Assistant Trey Fulkerson, who gave many of the sermons and led all the services. Thanks also to Annie Engelbrecht for providing most of the children's' sermons.

Worship during the pandemic: In-person services were suspended in March due to the COVID-19 pandemic. In June, Session created a task force to consider reinstating in-person worship using appropriate safety protocols.
